**ANTIQUÉ TRACTOR and FARM IMPLEMENT EXHIBIT ENTRY FORM**

**EXHIBIT DETAILS:**

- To be eligible, **tractors** must have been built **BEFORE 1981** and **farm implement BEFORE 1960**.
- Tractors/implements must be in place no later than Wednesday, July 12<sup>th</sup> at 2 PM. Any tractor/ implement brought in after 2 PM without prior arrangements will not be allowed to enter.
- Tractors/implements must be removed by Sunday, July 16<sup>th</sup> between hours of 9 AM and 12 Noon.
- Judging will be Expert Voting only which will be completed on Friday, July 14<sup>th</sup>. Judges and time of judging are confidential.
- Tractors will be judged with ribbons for 1<sup>st</sup>, 2<sup>nd</sup> and 3<sup>rd</sup> place in each category. 1<sup>st</sup> place winners in each tractor category will also receive prize money as follows:
  - **Oldest Tractor - \$30.00**
  - **Best Original Condition Tractor- \$50.00**
  - **Best Restoration Tractor- \$50.00 [must include before and after photographs]**
  - **BEST in SHOW Tractor - \$100.00**
- Implements will be judged with ribbons for 1<sup>st</sup>, 2<sup>nd</sup> and 3<sup>rd</sup> place. There are **no** cash prizes for implements. **Implements display is primarily for educational purposes.**
