The cost to be a vendor is \$60 for a business and \$30 for a non-profit organization.

This year we are, again, offering two types of upgrades on a first-come basis as they are very limited.

- 1) Corner booth for an additional \$25 fee.
- 2) Electricity for an additional \$25 fee.

The festival does NOT provide any type of tent or covering for the space provided.

Once your application is accepted you will be given further instructions as to logistics on the day of the event.

To avoid duplication of product, Ladysmith Day Festival does its best to make space available on a first-come basis. The festival will keep a list of applicants so if a vendor backs out 60 days before the event the second applicant will be contacted if interested.

**There is a \$50 fee for returned checks.**

All vendors need to be sure they have a Caroline County Business License. Please call the office of the Caroline County Commissioner of Revenue at 804-633-1086 or email [commissioner@co.caroline.va.us](mailto:commissioner@co.caroline.va.us) for information and/or an application for a Caroline County Vendor License and information concerning Virginia Sales Tax.

All vendors must have their space in place and their vehicle clear of the exhibit area and parked in the designated area by 10:30 a.m. the day of the event.

**Vendors are not allowed to tear down their space and leave the area prior to the closing time of 4 p.m. Vehicles are not allowed into the exhibit area until they are allowed to do so by event staff. This is a safety issue. Vendors who attempt to tear down their space prior to this time will not be invited back**

**All vendors must provide a Certificate of Liability Insurance or sign the Hold Harmless Agreement to participate. No exceptions!**

**ALL FOOD VENDORS must provide a Certificate of Liability Insurance with this application.**

**All Certificates of Liability Insurance must include the following language: "Additional Insured: Caroline County Agricultural Fair Association, Ann H. Tate, and Ladysmith Day II, Inc."**

Ladysmith Day Festival is a rain or shine event and there are no refunds because of weather.

Be sure to sign the **INDEMNITY (HOLD HARMLESS) AGREEMENT** below and return with your application, necessary paperwork and check.
